- 4. Provides training and supervision on health and safety issues, such as safe working practices and emergency procedures, in order to enhance employees' understanding of occupational hazards.
- 5. Ensure that all employees, visitors and other exposed persons have knowledge, understanding and application of the Company's Safety Guidelines in the workplace.
- 6. Ensures the financial resources for the implementation and continuous improvement of the Health and Safety System implemented by the company.
- 7. Implement procedures to analyse and evaluate all accidents and incidents related to safety in the workplace.
